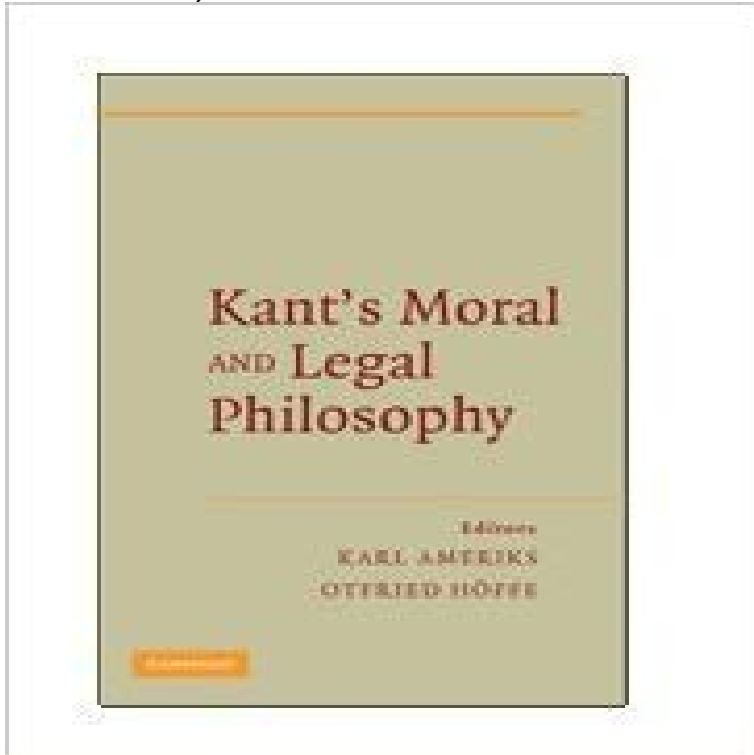


# Kants Moral and Legal Philosophy (The German Philosophical Tradition)
